- Full membership is open to any manufacturer engaged in manufacturing and selling "builders hardware", doors and door components in the United States, Canada or Mexico shall be eligible for membership in the Corporation. "Manufacturer" means a firm in the defined geographic area (United States, Canada or Mexico) that bears financial and legal responsibility for raw materials, plant, equipment and personnel utilized in "substantial manufacturing activities" and that is responsible for the quality of the product so produced.

- "Substantial manufacturing activity" means producing in the defined geographic area (United States, Canada or Mexico) builders hardware, doors and door components by taking raw material or semi-finished material and fabricating, converting or producing therefrom semi-finished or finished builders hardware, doors and door component products for sale commercially. The term "substantial manufacturing activity" means significantly more than simply importing, packaging and warehousing.
